## DALHART CITY COUNCIL REGULAR MEETING TUESDAY, AUGUST 14, 2018

The Dalhart City Council met in regular session in Council Chambers on Tuesday, August 14, 2018 at 6:00 p.m. Phillip Hass, Mayor, called the meeting to order. A quorum was present. Rusty Hancock led the prayer. Members present were:

Brian Walton made a motion to approve the Consent Agenda, consisting of minutes of the previous Regular Meeting on July 24, 2018. The motion also included the approval of the July Financial Report, July Tax Report and July bills in the amount of \$712,443.55. Brian Walton made a motion to approve the recommendation of the Planning & Zoning Commission and conduct the first reading of **Ordinance 2018-16**, on the proposed zone change of Lots 1-4, Block 107, Blair Division, City of Dalhart, Dallam County, Texas from Multi-Family to Special Use Zoning to place a new manufactured home.

Mayor Hass opened the first Public Hearing and second reading of **Ordinance 2018-14**, on the proposed zone change of Lot 8, Block 69, Blair Division, City of Dalhart, Dallam County, Texas from R-3 Residential to Special Use Zoning to place a manufactured home. This property is under contract. David & Lori McCarter own the property and Alejandro & Athziri Ruiz are purchasing the property from the McCarter's. The property is located at 1215 Dallam. There was no one from the Public in opposition of the re-zone.

Mayor Hass opened the second Public Hearing and second reading of Ordinance 2018-15, on the proposed zone change of the S part of N106' of the W/2 of Kendrick Tract, Sub 3, Section 31, Block 48, H&TC RY Co, City of Dalhart, Dallam County, Texas from R-3 Residential to Special Use Zoning to place a manufactured home. There was no one from the Public in opposition of the zone change. Troy & Kathleen Lysford are asking for the re-zone located at 505 Tennessee. Clinton Hale made a motion to close the Public Hearing. Billy Sisco seconded the motion and the same carried unanimously.

Brian Walton made a motion to adopt Ordinance 2018-15, re-zoning the S part of N106' of the W/2 of Kendrick Tract, Sub 3, Section 31, Block 48, H&TC RY Co, City of Dalhart, Dallam County, Texas, from R-3 Residential to Special Use Zoning to place a manufactured home. Tim Yee seconded the motion and the same carried unanimously.

James Stroud, City Manager, conducted the second budget workshop. Stroud stated that the proposed budget includes two (2) bathrooms for two (2) of the city parks, ½ ton pickup for the parks department, two (2) patrol cars, and a commercial washer & dryer for the Fire Department for their bunker gear. There are also several other items to be added to the proposed budget.

Mayor Hass appointed Sherri Haschke, Bryan Brewer, Brian Walton and himself to the salary committee. They will meet and report back to the City Council at the August 28, 2018 regular meeting.
