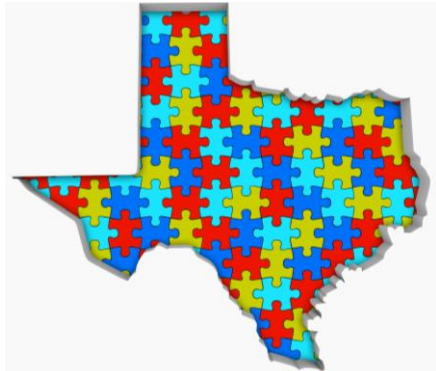

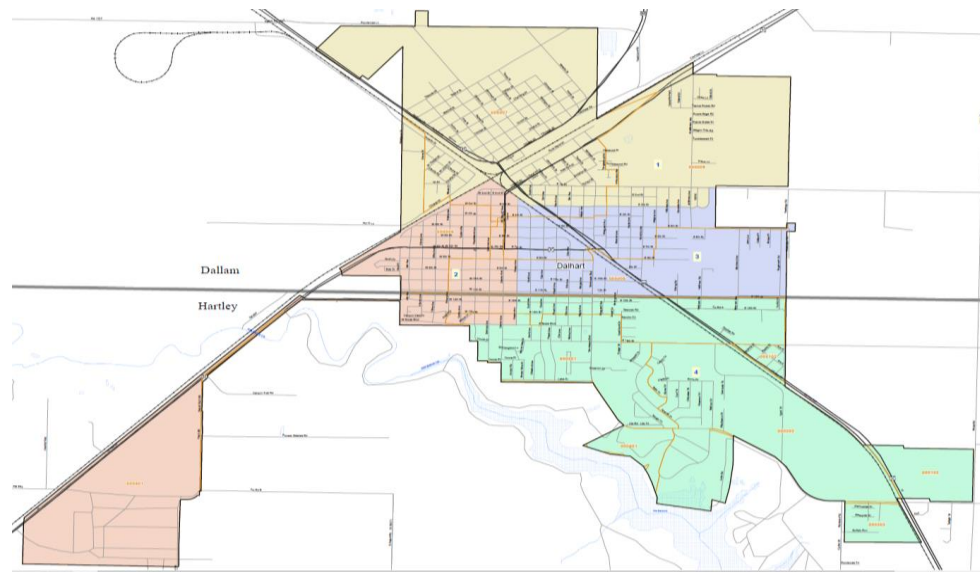
Dalhart's Initial Assessment

Big Picture

- Total Population for 2020: **8,400**
- Total Population for 2010: 7,930
- Ideal Ward Size is **2,100** people per ward (8,400 / 4 = 2,100)
- Ward 4 is the largest ward. Ward 2 is the smallest ward:
 - **Ward 4 has 2,496 people which is 18.86% deviation from Ideal Size**
 - **Ward 2 has 1,652 people which is -21.33% deviation from Ideal Size**
- Cannot have a Total Deviation of more than 10%
- Current Total Deviation is **40.19%**
- What now? We redistrict!

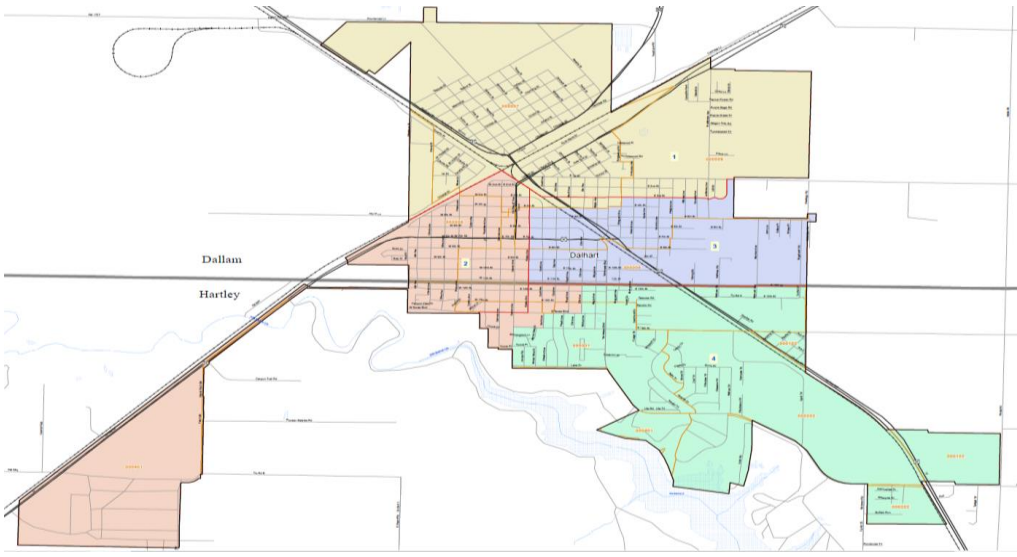

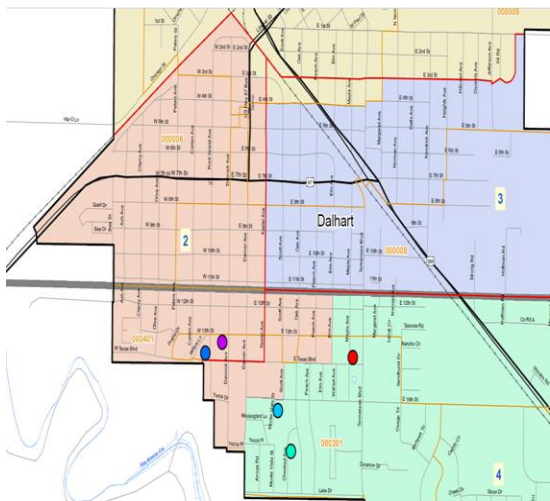

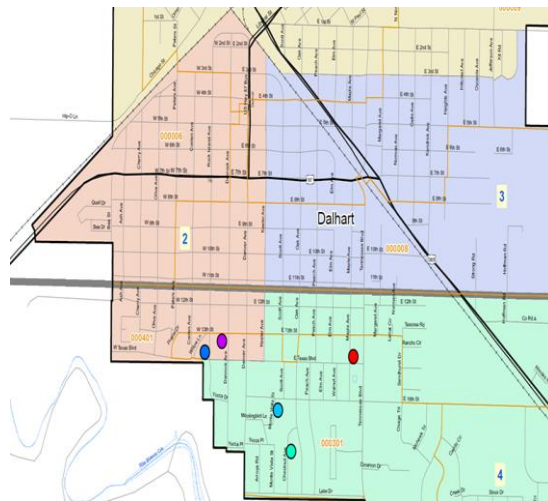

Existing Boundaries Map



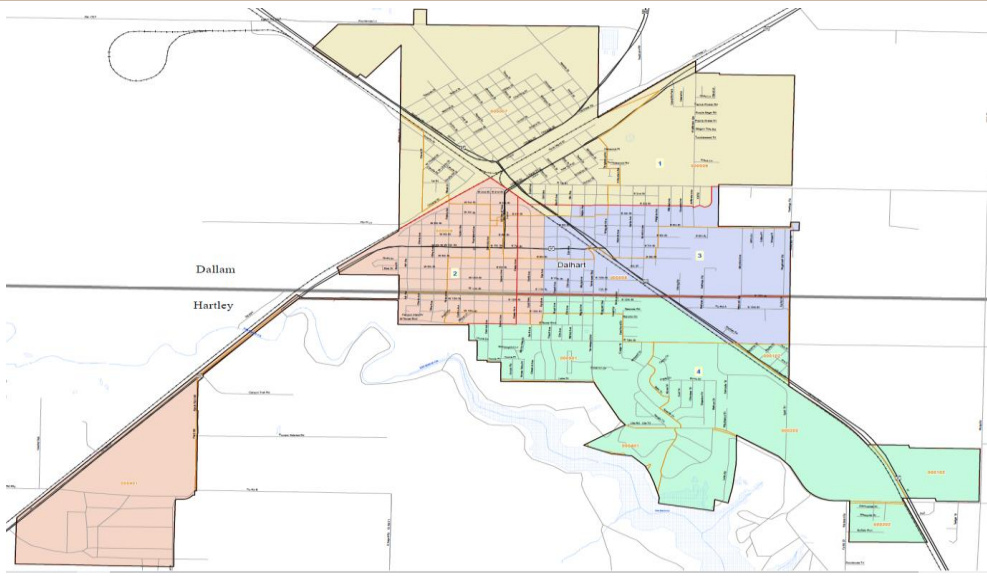

What Changed

- Draft Map A Total Maximum Deviation: 6.48%
- Wards 1, 2, 3, and 4 were redrawn.
- Ward 1 would have 94 more people under Draft Map A (2,117).
- Ward 2 would have 354 more people under Draft Map A (2,006).
- Ward 3 would have 94 less people under Draft Map A (2,135).
- Ward 4 would have 354 less people under Draft Map A (2,142).
- No substantial retrogression in Minority voting power.

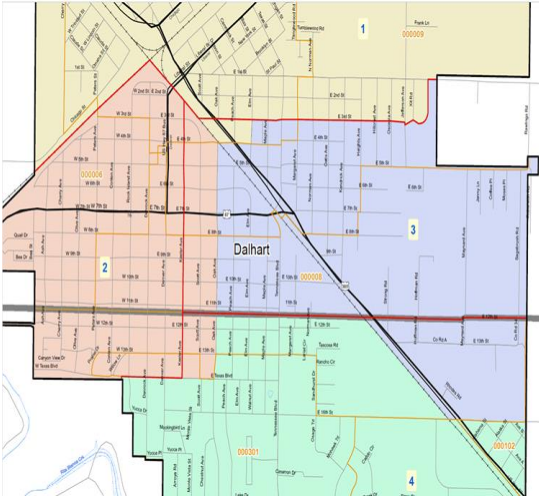

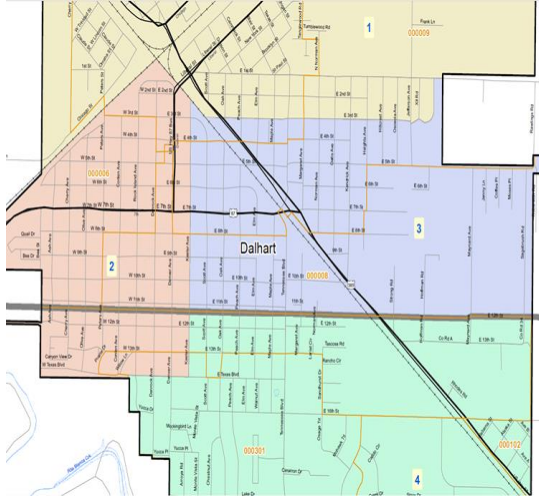

What Changed

- Draft Map B Total Maximum Deviation: 5.62%
- Wards 1, 2, 3, and 4 were redrawn.
- Ward 1 would have 24 more people under Draft Map B (2,047).
- Ward 2 would have 513 more people under Draft Map B (2,165).
- Ward 3 would have 170 less people under Draft Map B (2,059).
- Ward 4 would have 367 less people under Draft Map B (2,129).
- No substantial retrogression in Minority voting power.

The Process: Next Steps

- Obtain local population data
- Conduct Initial Assessment
- Establish Criteria, Guidelines, Policies & Timeline
 - Presented as Resolutions for Adoption by Council
- Compile Initial Preferences of Council & Staff
- Determine Approach to Civic Engagement
- Commence Map Drawing
- Civic Engagement
- Possible Plans:
 - Illustrative Maps are internal versions intended for informal feedback
 - Draft Maps are public versions for which public comments are solicited
 - Citizen Maps are submitted by outside parties for public comment & city consideration
- Adoption of new Plan by City Council
- Final Report to City Council
