DALHART CITY COUNCIL REGULAR MEETING TUESDAY, JANUARY 14, 2020

The Dalhart City Council met in regular session in Council Chambers on Tuesday, January 14, 2020 at 6:00 p.m. Clinton Hale, Mayor Pro-Tem, called the meeting to order. A quorum was present. Rusty Hancock led the prayer. Members present were:

Brian Walton made a motion to approve the Consent Agenda, consisting of minutes of the previous Regular Meeting on December 10, 2019. The motion also included the approval of the December Financial Report, December Tax Report and December bills in the amount of \$1,014,102.98. There were no Public Comments.

Gayla Fullerton, CPA PLLC, was present to give the audit for the 2018-2019 Budget Year. Brian Walton made a motion to approve the audit. Tim Yee seconded the motion and the same carried unanimously.

Mayor Pro-Tem Hale opened the Public Hearing and second reading of **Ordinance 2019-22**, captioned as follows:

AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR THE CITY OF DALHART, TEXAS; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

Brian Walton made a motion to close the Public Hearing and adopt **Ordinance 2019-22**. Tim Yee seconded the motion and the same carried unanimously.

Brian Walton made a motion to approve the recommendation from the Planning & Zoning Commission and conduct the first reading of **Ordinance 2019-21** on the proposed zone change of the following:

A 13.32 ACRE TRACT OR PARCEL OF LAND BEING A PORTION OF THAT CERTAIN TRACT OR PARCEL OF LAND AS RECORDED IN VOLUME 146, PAGE 401, OFFICIAL PUBLIC RECORDS OF DALLAM COUNTY, TEXAS, BEING OUT OF SUBDIVISION 7, SECTION 31, BLOCK 48, H&TC R.R. SURVEY, HARTLEY COUNTY, TEXAS, SAID TRACT OF LAND HAVING BEEN SURVEYED ON THE GROUND BY FURMAN LAND SURVEYERS, INC. ON MAY 16, 2017 AND BEING FURTHER DESCRIBED BY METES AND BOUNDS.

This proposed zone change is from R-3 Residential to Special Use Zoning for the construction of a Recreation Center. Bryan Brewer seconded the motion and the same carried unanimously.

Brian Walton made a motion to award the bid for concrete for 2020 to XIT Concrete. Their bid was as follows:
